Action Letter 01-13

- Facebook “friending” and Twitter “following” of cadets by officers is now considered Fraternization

[Standards of Conduct ¶17; Region 1-1 INST 02-2013; Region 1-3 Policy Statement 01-12]

- A new MIDN must delete all current cadets from any personal social networking accounts
- Relatives are excepted
- “Fan Pages” are excepted

- Cadets may not be used to improve an individual’s personal property, even in the name of training

[Standards of Conduct ¶12]



Action Letter 01-13

- New guidelines for appointment to Warrant Officer
[Administrative Manual 0204.2]
 - One year as INST, OMSG, & OPD 101
 - ≥ 8 years active/reserve, minimum E6
- PO1 & CPO Packets must be endorsed by CO, RD, and NHQ Rep before arriving at NHQ [ATM Ch. 3 ¶A(2)(c)]
 - Include CAPT Bruni's Checklists (NE Field Region Form 1/2)



Action Letter 01-13

- Changes to criteria for NLCC Cadets transferring to NSCC as E2-T [ATM Ch. 3 ¶A(1)(h)]
 - ≥ 1 year in NLCC, NLCC Orientation, \geq LC4, BMR
- NLCC Cadets must attend NLCC Orientation before attending any other NLCC training [ATM Ch. 3 ¶C]
- NSCC Units may not own cars, vans, buses, or boats [NSCC Regulations 1224.1 & 1440.2]



Northeast Region Action Letter 01-13

- From CAPT Bruni on 15JAN13
- “No one that is not enrolled in the NSCC is authorized to participate in any NSCC activity.”
- Non-enrolled adults may not be unsupervised with cadets at any time
 - This includes guest instructors!
- “Shadowing” is a one-time opportunity



Information Letter 02-13

- 2013 Scholarship Opportunities
 - 13 scholarships worth more than \$32,000 total
 - Often only a few more applications than there are scholarships
 - NSCADM014 and supporting documents are due to NHQ by 01 May 2013
 - Get your seniors started on this process!
 - See NSCC Regulations Chapter 16
